## **Introducing '*War, Law and Business*'**

### **International humanitarian law for future business leaders**

Welcome to *War, Law and Business*, an interactive and immersive experience on international humanitarian law (IHL) for future business leaders! It is free to do and accessible to all via:

#### **The objective**

This module is designed to introduce future business leaders – at university or already in industry – to the relevant rules and principles of IHL. Throughout this module, students will learn about IHL as an ethical decision-making and evaluation framework that helps one manage the unique risks associated with doing business in a conflict-affected area. Most importantly, respecting and promoting IHL protects the lives and dignity of civilians and communities.

The significant increase in the number and complexity of armed conflicts is presenting new challenges for those doing business in these environments, and for those seeking to improve humanitarian outcomes for impacted individuals and communities. Consequently, business decision-making in conflict-affected areas comes with significant responsibility and requires informed and nuanced leadership and risk-management; not least, an understanding of the risks, rights and responsibilities under all relevant international legal frameworks. This includes the specialised legal framework that regulates behaviour in situations of armed conflict, which is known as IHL or the laws of war. The idea behind IHL is simple and compelling: even wars have limits.

In this module, the participant plays the role of CEO of Ruskin Resources – a global, diversified (and fictitious) extractives company. They must learn and apply the fundamental rules of IHL to help navigate a conflict-related crisis.

#### **Intended audience**

*War, Law and Business* has been designed for students in **business-related disciplines**. The module is relevant to a range of study-areas – the social responsibilities of business, business leadership and ethical decision-making – so is conducive to integration into a range of courses. It aims to teach business students the significance and relevance of IHL to the corporate world and is the first educational tool of its kind.

*War, Law and Business* is also **suitable for law students**. Traditional international law and IHL courses invariably focus on the applicability of IHL to governments and military actor. The applicability of IHL to businesses – as significant societal actors that operate in, or have supply chains in, conflict-affected areas – is often excluded from traditional IHL education. This module thus provides an additional perspective on the relevance and value of IHL to regulating behaviour in conflict-affected areas.

Finally, this module is **relevant to those already in industry, including early career professionals but also business managers, lawyers and in-house counsel, security personnel and other professionals**. The insights shared in this module will be useful in helping corporate actors deepen their knowledge

and understanding of IHL, and its relevance to business operations in fragile states and conflict-affected regions.

### Possible usages

This module can be used in a range of ways:

- As stand-alone training or continuing professional development;
- As an additional, voluntary learning activity; or
- Integrated into the core teaching and learning of a relevant university course.

The module can be deployed as a single, standalone learning experience. It is fully-self-contained, including a brief assessment at the end and certificate of completion from Australian Red Cross and RMIT University. Therefore, it can be offered as an “Additional Activity” or type of “Microcredential” related to a course.

*War, Law and Business* may also constitute a 1.5-hour Continuing Professional Development (CPD) activity for the legal profession (under Australian standards). Noting that CPD requirements vary between different jurisdictions, so users should investigate the specific rules in their own State or Territory.

The module can also be used as a basis for discussion and deeper learning. Contained in this pack are some discussion questions to help facilitate such dialogues in tutorials or workshops after completion of the module.

### Learning objectives

At the end of this module, users should be able to:

1. Identify fundamental principles of IHL including distinction, humanity and proportionality.
2. Recognise factors that impact application of IHL in a business-related situation
3. Describe the risks and responsibilities inherent in doing business in and beyond conflict areas
4. Explain the urgency of companies becoming familiar with IHL
5. Identify resources for increasing understanding and application of IHL, including the *Seven Indicators of Corporate Best Practice in International Humanitarian Law*
